An application to register the trade-mark has been filed by the applicant in and for **InsertCountry**, the country of origin of the applicant, on **InsertFilingDate** under no. **InsertApplnNo.**, in association with **InsertWaresServices**. The applicant intends to use* the trade-mark in association with the aforementioned wares and/or services in that country, and requests registration of the trade-mark upon its registration in that country, in respect of the wares and/or services in association with which the trade-mark will have been used as aforesaid and which are covered by the registration in that country.

10. The applicant claims priority under section 34 of the Act on the grounds that an application for registration of the same or substantially the same trade-mark was filed by the applicant in **InsertCountry** on **InsertFilingDate** under no. **InsertApplnNo**, and that such application was the earliest application filed in any country of the Union other than Canada by the applicant or any predecessor in title of the application, for the registration of the same or substantially the same trade-mark for use in association with the same kind of wares and/or services set out above. At the date of such application the applicant was a citizen or national of or domiciled in the country aforesaid, or had therein a real and effective industrial or commercial establishment.

11. The applicant appoints **Firm/Representative**, whose full post office address in Canada is **Street number, street, city, province, country, postal code**, as the firm to which any notice in respect of the application or registration may be sent, and upon which service of any proceedings in respect of the application or registration may be given or served with the same effect as if they had been given to or served upon the applicant or registrant.
